# MASTER'S STUDIES

Master's studies lasts two years (4 semesters) and ends with obtaining a master's degree. The exception is Financial Audit, which lasts 2.5 years (5 semesters) and Spatial Management, International Logistics, Commodity Science and Production Management and Engineering -1,5 years (3 semesters).

To apply for master's studies candidates need to present their bachelor's degree (diploma of completing first cycle studies and diploma supplement).

# **DOCUMENTS NECESSARY FOR ADMISSION TO STUDIES:**

- diploma of completing first cycle studies\*
- diploma supplement
- passport copy
- personal questionnaire
- form with data for the candidate's index
- Polish sworn translations of all foreign documents
- statement of citizenship
- it may be necessary to officially recognise if the Bachelor's Diploma allows you to undertake Master's studies. Such certificate may be issued by the equivalent of Ministry of Education in a given country (such document needs be translated into Polish by a sworn translator)





# ADMISSION STEP BY STEP:

### 1 stage:

- create an account on the Online Candidate Admissions website (irk.uek.krakow.pl)
- pay the admission fee (individual account number available on your admission account)
- send all documents necessary for admission to the Teaching Department (studiainfo@uek.krakow.pl)

ATTENTION! Remember that only properly completed and paid-for forms are considered in the admissions process!

### 2 stage:

• submit the documents necessary for admission in person to the Teaching Department (rooms 107-108)

ATTENTION! A third party may submit the documents on behalf of the candidate. In such a case authorisation is required.

### 3 stage:

- deliver original and copy of your visa, residence permit or registration of stay
- submit original and copy of health insurance

## **DEADLINES:**

International students may apply for studies from June/July (the exact date of admission will be available soon).





# **TUITION FEES:**

International students are required to pay the following semester fees for studies in Polish:



- second-cycle studies PLN 5,300
- long-cycle studies PLN 6,600

For studies in English applies following semester fees:

- full-time studies **PLN 3,000**
- part-time studies **PLN 4,700**

The following are exempt from paying tuition fees:

- nationals of member states of the European Union, the Swiss Confederation or the European Free Trade Agreement (EFTA)
- candidates with a permanent residence permit or long-term EU residence
- candidates with a temporary residence permit in connection with the circumstances referred to in Article 159 section 1, or Article 186 section 1 point 3 or 4 of the Act of 12 December 2013 on Foreigners (Journal of Laws of 2017, point 2206 and 2282, and of 2018, points 107, 138 and 771)
- refugees in the territory of the Republic of Poland or candi dates with temporary or subsidiary protection in the territory of the Republic of Poland
- holders of a Card of the Pole, or the document confirming Polish descent
- candidates with a certificate of proficiency in Polish at C1 level
- candidates who are spouses, ascendants or descendants of a citizen of the Republic of Poland, residing in the Republic of Poland

The exemption from fees may also be granted on the basis of:

- Rector's decision
- decision of the Minister or decision of the NAWA Director
